Both the North Linden Neighborhood Plan Amendment (2014) and the Columbus Citywide Planning Policies (C2P2) recommend that garages be located and accessed from the rear of the property for those properties with alley access. For garages that face the front elevation, the garage width should not exceed 40 percent of the home's width. C2P2 also encourages front porches for new houses and that new single family homes should be oriented to the street and reflect the prevailing setback and spacing of nearby homes, as appropriate.*
